The United States District Court for the Eastern District of Pennsylvania is soliciting proposals from vendors to provide treatment services for male and female Federal Defendants who are on Pretrial Supervision while on bail conditions of the U.S. District Court.

All of our current treatment contracts terminate on September 30, 2021, and the new contracts will be effective on October 1, 2021. We have posted our Request for Proposal (RFP), which can be found on our District's Internet website in order for you to select which services your Agency can provide. Upon entering the website, at <http://www.paapt.uscourts.gov>: please select 1) Client Treatment, followed by 2) Solicitations and complete the required information underneath the Request for Proposals link. If you are interested in providing treatment services to Pretrial Defendants, please visit our website or forward this information to the appropriate staff at your program. If you are interested in providing multiple services to our District, or the same service in multiple locations, you will need to submit a separate RFP for each. If you have multiple offices in various areas, and want to provide services from each office, please include all addresses in your Proposal. Also, **DO NOT** re-type the Blanket Purchase Agreement (BPA), simply add your information to the document and return all required documents to our office. Please return all required documents that are provided on the RFP in addition to the supplemental documentation from your Agency.

Please note that all Request for Proposals must be received in this office no later than Thursday, July 15, 2021 by 4:00 p.m. Vendors who may have questions regarding the RFP may send them to paapt_business@paapt.uscourts.gov, no later than Monday, July 12, 2021 by 4:00 p.m.

Each Proposal must contain an original signature. An original and one copy of the entire packet must be received, with a copy of the entire packet retained by the vendor. Do not submit Proposals in binders or notebooks. We thank you in advance for your efforts during this contracting process.
